**INHERENT RISKS:** fractures, sprains, heatstroke, dizziness, bruises, hyper ventilation. Pregnant women and those at a high risk of heart attacks or strokes cannot partake in these activities. Those considered overweight (250 lbs or more) and those in poor physical condition should be fully conscious of the extent of this activity and consider not taking part in them.

**RULES AND REGULATIONS OF THE PARK OF ARBRE AVENTURE, CANOPÉE ESTRIE Inc.**

- It is prohibited to be under the effects of drugs or alcohol while in the high ropes course.
- You must attend the initiation session prior to taking part in the high ropes course.
- You must always be attached to the safety line using both carabineers. NEVER unhook both carabineers at the same time.
- Kids under 14 must be accompanied by an adult at all times (1 adult for a maximum of 3 kids)
- You cannot be more than 2 people per platform, 1 per activity, and 1 per zip line.
- Smoking is prohibited in the high ropes course, in the forest, and inside the shack.
- It is prohibited to walk outside the paths provided.
- The direction of Arbre Aventure, Canopée Inc reserves all rights to exclude anyone from further participation that does not abide by these safety rules without any warnings or refunds
- The night courses are reserved for those over 16 years of age. A parent or guardian signature is mandatory for those under 18 years of age.
- In case of rain, activities at Arbre Aventure will not be interrupted; therefore there will not be any refunds or compensation.
- In case of thunder or violent winds, those in charge of the park of Arbre Aventure Canopée Inc reserves all rights to interrupt all activities in order to ensure the safety of its clients
- It is mandatory for the Tall Tarzan and Zip lines to use gloves, and only those provided by Arbre Aventure, Canopée INC.
- Clients must wear sport clothing and must at all times have their hair well attached.
